#### **General Membership Meeting Minutes**

March 21st, 2023

The meeting was called to order at 7:00 pm by President Jerry Baker. A roll call of officers was called and those in attendance were, Jerry Baker - President, Gregory Kensbock - Secretary, Roberta Vasilow - Treasurer and Mark Oliver – Member at Large.

There were 15 members present for the meeting and 3 regular members (5 total) attending on Zoom. There were 2 guests attending on Zoom, Noah Becker KE8CFH and Jeff Metiva KB8SWR.

The Treasures report was called for and given by the Treasurer who reported that we have a balance of \$4,978.64 on deposit, a motion to accept the report as given was voted on and passed. A reading of the minutes of the last meeting was given by the secretary, and a motion to accept the minutes as read was made and a vote was taken and passed. The Member at large was asked if he had a report and he stated he had none at this time.

#### Old Business,

The first item up for discussion was the Constitution; The president referred to the e-mail that was sent to all regular members of the club with a copy of the Constitution and its proposed changes for the purpose of the membership's consideration, comments, or suggestions to be brought up at the membership meeting (tonight's meeting). The President asked for volunteers to serve on a six (6) person committee to go over the Constitution. Three of which that were involved in the initial proposals and three others. And come up with a final version to be submitted for approval. Those who volunteered and were accepted are Karl Collyer (KD8ZCL), Jeff Parker (KE8ICG), Mark Oliver (N8REA), Mark Smith (WB8KKZ), David Gamage (N8MME) & Jerry Baker (KD8AYL)

It was then asked if there was any discussion on the Constitution for the committee to add for membership consideration the following was suggested for consideration,

- 1.To drop the section pertaining to an emergency Coordinator.
- 2. The legality of voting electronically (Zoom) over being in person.
- 3. Whether we need a constitution or a set of By-Laws.
- 4. What to do with our equipment (repeaters etc.) if we ever dissolve the club.
- 5. The consideration of adding a Vice President to the board.
- 6. The addition of a conflict-of-interest clause.

Clayton gave a report on Elms Road Park as to it not being a suitable site for Field Day due to all the new remodeling being done. Madison Academy School was then brought up as a possible site for Field Day, Jeff stated he lived across the street from the park and would check into the possibility as a site for Field Day.

#### New Business,

The President stated he's been in touch with officials concerning the Crim race and will relay details as they become available. He then brought up our helping with the food drive on the 1<sup>st</sup> Sat. in April at the church. Al Smith and myself gave a short talk on the ATU that I built and will present at the next meeting. The President then asked for any more comments, seeing none a motion to close was made and seconded the meeting was closed at 7:39pm
